WHAT IS THE ANNUAL FUND?

The Annual Fund was established in 1992, as a way to bridge the gap between tuition and the full cost of educating our students; tuition revenues do not cover the entire operating budget of the school. The full annual cost to educate a student is \$9,522, while the average yearly tuition cost is \$8,138. The Annual Fund makes up that crucial difference.

WHY DON'T YOU JUST RAISE TUITION?

We work hard to keep costs down so that St. Laurence Catholic School continues to be as affordable as possible. This opens the doors for families who want their children to be guided through faith, learning and leadership. Gifts to the Annual Fund are voluntary and are therefore tax-deductible, unlike tuition.

HOW ARE THESE FUNDS USED?

Gifts to the Annual Fund contribute to the school's operating budget. This includes:

- Teachers' salaries
- Professional development
- Technology upgrades
- Maintenance and upgrades to facilities
- Sibling discounts
